

TERMS OF BUSINESS

Booking Deposit

A non-refundable initial deposit is required at the time of booking. Dates can only be reserved when this deposit has been made. Please make all cheques payable to Graham Beardsley. A booking cannot be confirmed until the deposit and booking form is returned.

Balance Payment

The outstanding balance is due no later than two weeks before the date of the venue. If the balance is not received by the due date, it will be taken as the venue is cancelled and my services are not required.

Re-orders

Any re-orders placed are accepted only on the condition that they form and extension of this contract and that the total amount should be paid when the re-order is placed. No orders will be released without payment in full.

Photographs taken

Subject to weather and the availability of subjects, Graham Beardsley will endeavour to take all the requested photographs, but cannot guarantee any specific picture or group arrangements. In the unlikely event of total photographic failure, liability shall be limited to a full refund of all monies paid, with the exception of the initial booking deposit.

Colour previews

Graham Beardsley does not proof colour photographs. Previews are shown (size relates to the package chosen) from which you make your choice. Previews are then returned and the chosen photographs placed into your album.

Colour Matching

Colour photography is undertaken within the technical limitations of the process, as true colours in some cases are unobtainable in a photographic process. Colours may not necessarily be facsimile over the whole range of colours in a subject, and colour prints of the same photograph, but different in size or supplied at different times may show slight colour variation.

Copyright

The 1998 Copyright, Design & Patents Act assigns copyright to Graham Beardsley and copyright in all photographs including but not limited to, photographic prints and negatives, remains at all times with Graham Beardsley. You may not copy the photographs or allow copies to be made photographically, electronically or by any other means. Graham Beardsley reserves the right to use any picture for promotional or display purposes unless this has been agreed to the contrary in writing. It is the customers responsibility to ensure that any materials or items presented for photographing or use in a photographic way are free from any third party claim of copyright.

Cancellation

Upon signature, Graham Beardsley reserves the time and date agreed upon and will not make any other reservations for that time and date, for this reason, all deposits are non-refundable. In the event of another venue booking being made for your cancelled or postponed date, a full refund of your monies paid, excluding the initial deposit shall be given. If Graham Beardsley has to cancel for reasons beyond his control (death, injury, sickness etc) liability shall be limited to a refund, excluding deposit, of all monies paid. Should the cancelled date turn out to be a postponed of six months or less, and subject to Graham Beardsley's availability, all monies paid may be applied to the new date. In this case, the total fees chargeable shall be the initial booking fee plus the outstanding balance due no more than 2 weeks before the date of the venue.
